Whether you are looking to launch a new product, increase brand awareness or reach a target audience don't miss the opportunity to strategically position your business at the inaugural Upper Murray Agricultural Field Days.

Be part of a new venture that will support local business and their suppliers while promoting the magnificent Upper Murray region.

The Upper Murray Agricultural Field Days aims to introduce farmers, agricultural professionals, suppliers, workers, grain end users, local leaders and youth to existing and new farming equipment, technologies and techniques.

Exhibitors and stakeholders can maximise exposure to potential clients by utilising our workshop, speakers and/or training opportunities being scheduled throughout the Field Days with full conference facilities available.

Held in conjunction with the Man from Snowy River Bush Festival, the inaugural Upper Murray Agricultural Field Days will attract local and regional clients in the agricultural and business sector and draw on an existing crowd of Festival-goers (approx. 8,000 per day). The Old Corryong Consolidated School site is strategically located with open space for exhibitors to display wares, ease of access to main street, parking, toilet facilities and office/meeting spaces with conference capability. It is located close to other Festival venues and an easy walk for all participants.

HOW DO I APPLY?

Please ensure you have read and agree to the terms and conditions for participation at the Upper Murray Agricultural Field Days. Applications are accessed via an online portal. COMMERCIAL FOOD AND COFFEE VENDORS:

Food and Coffee Vendors are sought. All commercial food and coffee vendors are required to submit an application for their site at the Upper Murray Agricultural Field Days. Applications close 31st January, 2023

SITE ALLOCATION:

Site allocation will be at the absolute sole discretion of Upper Murray Agricultural Field Days. Organisers reserve the right to refuse applications on the grounds of unsuitability or if there are too many exhibitors of that product.

FACILITIES & SERVICES:

FOOD & REFRESHMENTS ONSITE:

There will be a range of food and beverage options available at community run and commercial outlets during the Field Days. Alternatively, it is an easy walk to Hanson Street eateries while on your break.

RUBBISH:

All rubbish must be placed in bins near your site. Prior to the start of the Field Days cardboard boxes and packaging materials can be folded flat and placed in skip bins provided. Ensure your site is left clear of all rubbish at the conclusion of the Event and when your Pack-up is complete.

SECURITY ONSITE:

Exhibitors will be responsible for maintaining security of their site throughout the Field Days. Exhibitors may choose to spend the night within their site to monitor its safety. Police will maintain a presence. Organisers will not be held responsible for any loss or damage to the exhibitor's property while on the site.

UNLOADING EQUIPMENT:

Free unloading facilities will be available Tuesday 11th April onsite to assist exhibitors set-up their sites. Bookings cannot be made prior to the Event. Unloading assistance will work on a first in first served basis. Please let us know in advance of especially large loads.

All items must be removed from Field Days site by close of business Friday 14th April.

MARQUEE & MARKET UMBRELLA HIRE:

Marquees and market umbrella will be available to hire by exhibitors at the time of registration. Prices include erection and dismantling. Exhibitors can arrive and immediately set-up without any fuss. Marquees range from 3m to 20m Structures subject to your requirements. To order simply provide details when you register online. * Invoicing with site fees.

EMERGENCIES & FIRST AID:

Exhibitors are encouraged to provide their own First Aid Kits for minor first aid requirements.

BAD WEATHER:

The Field Days will be staged regardless of weather. Ensure your site is secure in case of bad weather.

DISPLAY MATERIAL AND EXHIBITS:

Exhibitors are encouraged to make their sites look appealing and enticing. Exhibitors are responsible for making sure all display materials are secured correctly and safely. **Field Days Specials are ENCOURAGED.** Organisers reserve the right to remove any exhibit or item they feel may bring the Field Days into disrepute or that is deemed to cause offence.



ESSENTIAL INFORMATION:

FIRES:

The lighting of fires on the Field Days site is not permitted.

DEMONSTRATIONS:

Exhibitors are encouraged to use the opportunity to fully engage with their potential clients. Due to the size and location of the Field Days site extreme care and discretion must be used by exhibitors when it comes to demonstrating their machinery and/or equipment onsite - taking care to cause no damage to the Field Days environs or patrons. Organisers must approve all demonstrations prior to the Field Days.

COVID SAFE EVENT PLAN:

The Field Days Site will operate under the MFSRBF & associated events will run under Victorian Covid 19 public events framework/guidelines and any restrictions imposed by public health at the time of the MFSR Bush Festival. Please note compliance regulations are Fluid and subject to change.

Individual exhibitors must comply with the Victorian Covid 19 events framework and guide set Exhibitors are responsible for ensuring compliance of patrons in relation to their site.

NOISE:

Exhibitors are not permitted to use microphones or load hailers within the Field Days site. All exhibitors must be respectful of noise to neighbouring sites when carrying out demonstrations.

OPENING HOURS:

Sites must be staffed and operating for the hours of 9am to 5pm on Wednesday 12th and Thursday 13th April, 2023. Sites must remain intact until 5pm on Thursday 13th April.

VEHICLES & MOVEMENT RESTRICTIONS:

Exhibitors will only have vehicular access to the Field Days site during set-up and pack-up and/or after close of business each day, when patrons have left for the day and it is safe to do so. Please ensure all staff are advised of these restrictions.

The onsite speed limit is 10km/h.

Due to the Field Days site size, Exhibitors will need to park outside the site during open hours.



ESSENTIAL INFORMATION:

EXHIBITOR PASSES:

Passes will only be made available once full payment of your account has been received.

PUBLIC LIABILITY INSURANCE:

All exhibitors (inc any shared siteholders) must hold their own Public Liability Insurance with an indemnity of not less than \$20 million covering them against an occurrence attributable to their activities or the activities of any person for whom they are directly responsible. A copy of your current Public Liability Insurance Certificate of Currency is required with your application form.

RAFFLES & COMPETITIONS:

All games of chance and raffles where tickets are sold are not permitted without prior application in writing to the Field Days organisers. Organisers have the absolute sole discretion to refuse any application.

SAFETY:

To comply with the Work Health and Safety Act each exhibitor is responsible for the creation and maintenance of a safe environment for both their workers and visitors. The use of only safe and suitable extension leads and power boards is permitted. The safety of exhibitors, volunteers and visitors must be of utmost consideration at all times. Anyone conducting themselves in a manner dangerous to any of these groups may be asked to leave. Please exercise extreme caution and be aware of the safety of others when demonstrating or using machines or equipment onsite.

A fire extinguisher is recommended to be available on site by each exhibitor.

SUB-LETTING OF SITES:

Exhibitors shall not assign, lease, sub-lease, on-sell or part with the possession of the whole or part of their site. Only displays which have a genuine company link with an exhibitor can be shown on their stand. This means that unless an exhibitor owns, sells or distributes a particular line of product (or service) on a normal, continuing yearlong basis from the principal business house, it cannot be displayed.

All businesses represented on your site should be listed as a shared siteholder in order for all businesses at the Field Days to receive the best possible exposure.

TELEPHONE / INTERNET SERVICE / WI-FI:

Telstra 5G digital mobile phone coverage is available throughout the Field Days site.



ESSENTIAL INFORMATION:

ELECTRICITY, GAS AND POWER REQUIREMENTS:

Exhibitors are encourage to supply their own power generation equipment if it is required due to limited access to power within the Field Days Site. Use of silent (low noise) generators is preferred.

Exhibitors must only use and operate an approved portable power board with residual current device (RDS) earth leakage circuit breaker (ELCB) protection when drawing electricity from Field Days power supply. No double adapters are permitted. Exhibitors must supply an industrial power lead if they are connecting to Field Days supply.

For the safety of all Exhibitors, staff and visitors all electrical equipment or leads brought onto the Field Days site are required to have been inspected and tagged by a licenced electrical contractor which must be within 12months of the Field Days date.

Tampering of generators or electrical distribution box will not be tolerated.

Any gas bottles utilised as part of an Exhibitors site are not to be used within marquees or tents. They must adhere to and comply with all relevant Australian standards.

CODE OF CONDUCT:

Under no circumstances will any parties tolerate abuse, acts of violence, threats of violence and/or aggressive behaviour. This action may result in the party being asked to leave the site or removed by Police.
